# IV. APD Updates & Reports

### Rae Ann, Assistant PD – Off-Hill

- The Patrol refreshers are October 7th (CPR) and October 8th (OEC).
- The OEC class is going well. We have 8 candidates who are testing September 30<sup>th</sup>. We are pushing hard to get evaluators, patrol help and patients.
- The official Senior SEM test format will now be the two-scenario format without a warm-up. If a candidate fails one scenario, they will have the opportunity for one retest.
- Hoping to have a CPR instructor certification course at some point in the late fall.

## Nancy Trout, Assistant PD – On-Hill

Working on a new dry-land training program. Start date tentatively scheduled for October 5th.

#### Management

### **Refreshers**

- The patrol refreshers are scheduled for October 7 & 8. The 7<sup>th</sup> will be the chair evac and CPR and the 8<sup>th</sup> will be OEC. The CPR and Chair Evac refresher will be available in two 2.5 hour shifts half doing CPR and half doing chair evac and then switch.
- We are requesting patrollers with 3 year or less of service also complete chair evac training during the season
- Patrollers need to complete the on-line modules and sign-up for the Skill Refresher on the Center for Learning.
